Universal and correct wearing of masks	N	Face coverings are strongly encouraged for all students, staff and individuals, regardless of vaccination status while indoors and on school property to help prevent the spread at our schools. We urge families to consider this. Masks are available at all school sites for anyone who requests one.
Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	N	Physical distancing will be expected as much as feasibly possible.
Handwashing and respiratory etiquette	N	Hand washing or using hand sanitizer will be encouraged upon entering the classroom. Students and staff will be expected to wash their hands before and after restroom use. Frequent hand washing will be encouraged at regular intervals throughout the day with both soap and water, as well as hand sanitizer.
Cleaning and maintaining healthy facilities, including improving ventilation	N	Teachers and staff should clean their shared materials and devices after use. Cafeterias will be cleaned between lunches.
Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments	N	CCUSD will provide the current recommended guidelines put forth by the Maricopa County Department of Public Health (MCDPH) for isolation and quarantine to student families and staff.
Diagnostic and screening testing	N	CCUSD has COVID testing kits to distribute to families and staff when requested.
Efforts to provide vaccinations to school communities	N	CCUSD has hosted events on 4/17, 5/8, 6/28, 7/19, 9/17 and 10/1. CCUSD is hosting additional events on 11/12 and 12/3.
Appropriate accommodations for children with disabilities with respect to health and safety policies	N	School teams will meet with families to address concerns of students with unique health considerations.
Coordination with State and local health officials	N	CCUSD routinely communicates with local health officials from the Maricopa County Department of Public Health. Both District and campus leaders work with MCDPH when outbreaks are declared. In addition, District staff attend the COVID-19 webinars for schools provided by Maricopa County Department of Public Health (MCDPH).

### How the LEA will Ensure Continuity of Services?

CCUSD will ensure continuity of quality education services for all students by providing multiple instructional delivery models. This includes in-person instruction at all district brick and mortar campuses and an option for full-time or part-time online instruction to any student who chooses to enroll in our K-12 AOI school, the Cave Creek Academy of Excellence.

### Students' Needs:

Academic Needs	We believe we have met our students' needs by offering both in-person and virtual options to our students and their families. Students who became ill or quarantined remained in contact with their teachers via Google classroom for assignments and assistance. Schools offered additional assistance to help with any learning loss, for example a free Spring Break camp was offered to students to receive additional help in mathematics.
Social, Emotional and Mental Health Needs	Reorganized and assigned at least one counselor to each school in the district. Our counselors meet with students in classes, small groups and individually. We also have one social worker at our high school. Zoom appointments are available for our online students.
Other Needs (which may include student health and food services)	School teams will meet with families to address concerns of students with unique health considerations, as well as, work with our child nutrition department as needed. We have hosted 10 vaccination events in order to help meet the needs of our students and are prepared to host more should the need arise. Our child nutrition department is currently servicing all our schools and is prepared to shift to drive through pick up should the need arise in the future.

### Staff Needs:

Social, Emotional and Mental Health Needs	Increased flexibility of taking time off. We have offered additional mental health wellness training and awareness to all staff members. We have increased advertising for the counseling piece to employee benefits that many staff did not take advantage of in the past.
Other Needs	Increased flexibility of taking time off.

## Safe Return to In-Person Instruction and Continuity of Services Plan (ARP Act)

- (b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
  - (ii) In determining whether revisions are necessary, and in making any revisions, the LEA must seek public input and take such input into account
  - (iii) If at the time the LEA revises its plan the CDC has updated its guidance on reopening schools, the revised plan must address the extent to which the LEA has adopted policies, and describe any such policies, for each of the updated safety recommendations.
